

TERMS AND CONDITIONS

These Terms and Conditions apply to all individuals and organisations who register to fundraise for **Pankind – The Australian Pancreatic Cancer Foundation (ABN 35 131 461 190)** via the *Purple Collective* platform at fundraise.pankind.org.au/purple-collective. By creating a fundraising page or participating in any related activity, you agree to these Terms and Conditions in full.

1. Authority to Fundraise

By registering on this platform, you are granted a non-exclusive, time-limited **Authority to Fundraise** for Pankind. This authority is:

- Limited to the specific fundraising activity described on your fundraising page
- Valid for the duration of your active campaign (maximum 12 months unless renewed)
- Subject to compliance with these Terms and all applicable fundraising laws

If you wish to conduct **offline fundraising** (e.g. events, raffles, auctions), you are required to obtain separate written approval from Pankind. To request this, please contact us at info@pankind.org.au.

2. Fundraiser Conduct

As a fundraiser, you must:

- Act honestly, respectfully, and in good faith at all times
 - Accurately represent the purpose of your fundraising and the use of donations
 - Not collect cash or donations outside of the approved platform unless authorised
 - Not conduct any fundraising that may bring Pankind into disrepute

3. Use of Pankind Branding

You may use the official Pankind name, logo, and provided promotional materials **only in connection with your approved campaign**. You must not:

- Alter the logo or create your own versions
- Use Pankind's name in sponsorships or promotions without consent
- Represent yourself as an employee, agent, or official spokesperson

Pankind reserves the right to request removal of materials that misuse its intellectual property or violate these terms.

4. Online Fundraising Pages and Content

When creating and using your fundraising page, you agree:

- All images, videos, and text must be respectful, lawful, and not misleading
- You must not upload content that is obscene, defamatory, offensive, political, or racist
- You must have consent for any photographs of others that you share
- Pankind may review and remove any content at its sole discretion

Please do not include private contact information on public pages.

5. Children and Fundraising

Fundraisers **under 16 years of age** must have parent/guardian approval. Those under 12 must have direct supervision when setting up and managing a fundraising page.

Schools and youth groups must ensure appropriate oversight of any student-led activities, in accordance with child safety obligations.

6. Privacy

Pankind complies with the Australian Privacy Principles. Personal information you provide will only be used for the purpose of managing your fundraising activity and communicating with you. Our [Privacy Policy](#) outlines your rights and how we protect your information.

7. Termination of Authority

Pankind reserves the right to withdraw your Authority to Fundraise at any time if:

- You breach these Terms or applicable laws
- You conduct yourself in a way that could harm Pankind's reputation
- You use the fundraising platform for unauthorised or misleading purposes

We may disable your fundraising page without notice if a violation is identified.
